

YEAR END CITY COUNCIL MEETING MINUTES
APRIL 25, 2006 - 7:31 P.M.

Mayor Nolan called the Year End City Council meeting to order. Clerk Wells called roll. Aldermen present: Marzahl, Ulmer, Berg, Adams, Logan, Perkins and Hay. Alderman Leyden was absent. Also present were City Administrator Nelson, Building Inspector Santeler, Parks Supt. Burkart, Police Chief Oparyk, Public Works Supt. Carbonetti, Attorney Rob Fetzner, Gary Rozwadowski, Smith Engineering and members of the audience.

FY2006/2007 LIQUOR LICENSES - APPROVED

Mayor Nolan noted a change in owners for Windy's Lounge. Patricia Greco applied for the Class A Liquor License and the background check was satisfactory. The Mayor also reported that Fiesta Foods was sent the initial letter and application as well as a follow-up letter. To date, Fiesta Foods has not returned their application and fees. Moved to Berg, seconded by Logan to approve the paid Liquor License applications received to date, excluding Fiesta Foods, and that it is the City Council's determination that the number of licenses on the list as follows are the only licenses that are available. Further that the R1 liquor license for Bar Time to contain the provisions as outlined by the Ordinance Committee on April 5th, 2006, and is to be signed by Timothy Galvin.
