

**YEAR END CITY COUNCIL MEETING MINUTES
APRIL 28, 2009 - 7:00 P.M.**

Mayor Nolan called the Year End City Council meeting to order at 7:00 p.m. Clerk Wells called roll. Aldermen present: Leyden, Marzahl, Ulmer, Szczap, Adams, Logan, Perkins and Hay. Also present were Treasurer Meseck, City Administrator Nelson, Community Development Director Santeler, Police Chief Kazy-Garey, City Attorney Carlos Arévalo, Gary Rozwadowski of Smith Engineering Consultants and members of the audience.

RELINQUISH CLASS B LIQUOR LICENSE JOE OSCELLO, BRAVO PIZZA – APPROVED

Moved by Logan, seconded by Perkins to approve Joe Oscello's request to relinquish the Class B Liquor License for Bravo Pizza of Poplar Grove, Inc., d/b/a Bravo Pizza, 337 S. FY2009/2010 LIQUOR LICENSES - APPROVED

Mayor Nolan updated the City Council on the status of liquor license applications:

- Tim Galvin, Finn's Irish Pub, has paid the liquor license fee but has not yet paid the \$2,500 installment due from the creation of the Class A Liquor License. The Mayor recommends approval pending payment of the \$2,500.
- Harvard Short Stop, the corporation is not in good standing and the background is incomplete on the owner because the owner is out of the country. The Mayor recommended granting approval pending both items cleared up by June 1st, 2009.
- Guacamole Restaurant paid the fee, but the check was returned and liability insurance has not been received. The Mayor recommended approval pending receipt of payment via certified check and proof of liability insurance coverage.

Moved to Logan, seconded by Perkins to approve the following Liquor License applications effective May 1st, 2009, per the Mayor's recommendations; further that it is the City Council's determination that the number of licenses on the list are the only licenses that are available.
